11 Meetings Pursuant to AB 361.

13 **WHEREAS**, GREAT REDWOOD TRAIL AGENCY (“GRTA”) is committed to ensuring
14 public access to observe and participate in local government meetings; and

15 **WHEREAS**, all meetings of the GRTA are open and public, as required by the Ralph M. Brown
16 Act, so that any member of the public may participate in local government meetings; and

17 Whereas, the Brown Act, Government Code section 54953(e), makes provisions for remote
18 teleconferencing participation in local government meetings, without compliance with the
19 requirements 54953(b)(3), subject to the existence of certain conditions; and

20 **WHEREAS**, on March 4, 2020, Governor Newsom proclaimed a State of Emergency due to the
21 outbreak of respiratory illness due to a novel coronavirus (a disease now known as COVID-19)
22 and that State of Emergency is still in effect in the State of California; and

23 **WHEREAS**, the Sonoma County Public Health Officer, Marin County Public Health Officer,
24 Humboldt County Health Officer, and Mendocino County Health Officer continue to recommend
25 teleconferencing or social distancing during public meetings of all legislative bodies to protect
26 the community’s health against the spread of COVID-19; and

1 **WHEREAS**, the GRTA finds that the current conditions continue to meet the circumstances set
2 forth in Government Code section 54953(e)(3) to continue to use teleconferencing to hold open
3 and public meetings in compliance with the requirements set forth in Government Code section
4 54953(e)(2) to ensure the public can safely participate in and observe local government
5 meetings.

7 Now, Therefore, Be It Resolved:

8 **Section 1. Recitals.** The Recitals set forth above are true and correct and are incorporated into
9 this Resolution by this reference.

10 **Section 2. Current Conditions Allow Teleconference Public Meetings.** Based on the California
11 Governor's continued declaration of a State of Emergency and the above-stated health officers'
12 recommendations to continue teleconferencing or social distancing during public meetings, the
13 GRTA finds that the conditions continue to exist pursuant to Government Code section
14 54953(e)(3) to allow it to use teleconferencing to hold public meetings in accordance with
15 Government Code section 54953(e)(2) to ensure members of the public have continued access to
16 safely observe and participate in local government meetings.

17
18 **Section 3. Authorize Teleconference Meetings.** Staff is hereby authorized to take all actions
19 necessary to carry out the intent and purpose of this Resolution including, conducting open and
20 public meetings of the GRTA in accordance with Government Code section 54953(e)(2) and
21 other applicable provisions of the Brown Act.

23 **Section 4. Effective Date of Resolution.** This Resolution shall take effect immediately upon its
24 adoption.
