## A. CALL TO ORDER

Chair Marks called the meeting to order at 10:32 a.m.

**Richard Brand** – Mr. Brand said that he spoke with SMART regarding flaws in SB 1029 as it relates to freight service and he believes that freight operations should not be turned over to SMART.

**Allan Hemphill** – Mr. Hemphill said that recognition needs to be given to the NCRA for its years of dedicated work towards restoring freight service and for maintaining rail where economically feasible. He also said that NCRA must continue to advocate for rail service as directed by its mandate.

He said Caltrans has agreed to shutdown Hwy. 37 so that a much-needed repair to track surface across this busy highway can be accomplished.
