2. Discussion and Possible Action Regarding Design Revisions to Woodman Creek Fish Restoration Project

Chris Neary, Legal Counsel- Mr. Neary said that this item will need to be further reviewed for maximum cost savings efforts and requested that this item be continued at the April 11, 2018 Board of Directors meeting.

Public Comment:

Mike Wilson, Humboldt County Supervisor District 3 – Mr. Wilson said that the NCRA's Rails with Trails policy has some inconsistencies that are not affording the public the same access as the private entities in Humboldt County. He also said that he thinks that any revenues NCRA derives from the sale of excess property should be used in the communities where the excess rail property is located.

Chair Wagenet requested that Supervisor Wilson provide his comments in writing so that the NCRA Board has a better understanding of his specific concerns.

3. Discussion and Possible Action Regarding Letter to Caltrans Affecting Disposition of Excess Property

Public Comment:

Steve Honeycutt, Guillon Inc – Mr. Honeycutt updated the Board on progress on the Ukiah Depot project, the Mason Street property, and excess railroad property in Cloverdale.

Leishara Ward, Caltrans District 1 – Ms. Ward explained the process and requirements for declaring excess property.

She outlined a process that includes the below described elements and said that CTC staff could direct Dist. 1 staff to work with CTC staff to resolve excess property issues at the staff level without the requirement that NCRA address the CTC Commissioners at monthly CTC meetings.

- 1) NCRA submits a letter of intent to Caltrans requesting declaration of excess property;
- 2) Caltrans submits the request to the CTC for its review;
- 3) CTC reviews the request and grants approval in accordance with the Funds Transfer Agreement;
- 4) CTC authorizes Caltrans to handle the transaction;
- 5) Caltrans approves/denies the request

Director McCowen suggested that NCRA staff seek Caltrans' opinion prior to making an excess property determination.
