2. Discussion and Possible Action Regarding Approval of Lease Agreement, County of Humboldt Bay Trail South Project

Chair Hagele asked for Public Comment.

Uri Driscoll- Mr. Driscoll said he is concerned with the 60% design plan for the Humboldt Bay Trail South project and has submitted comments through the County and the Coastal Commission. He said he has concerns that the plan does not mention the types of usage for this trail or the difficulty it could present for speeders, rail bikes, trolleys, and other lightweight vehicles on specific sections of the proposed trail. He also said that the written testimony from THA has been submitted regarding this issue. He also said that the county should not remove any ties or rail unless and until railbanking is approved by the STB. He said any decision to do otherwise would violate STB guidance and invite legal challenges.

Karen Underwood, Humboldt Trails Council- Ms. Underwood said the Humboldt Trails Council serves as a unified voice in support of the development of trails for transportation and recreational use in

Humboldt County. She said the Trails Council has over 1,000 active supporters who sponsor the volunteer trail stewardship program that work on maintenance of trails with partner with cities and the county to create trail opportunities throughout Humboldt County. She also said that they are looking forward to the completion of the Humboldt Bay Trail South and that the final 4 plus miles of trail will complete the Arcata to Eureka connection, an important safety measure for bikers who currently compete with cars along the busy 101 corridor.

Emily Sinkhorn, Eureka resident- Ms. Sinkhorn said she feels the completion of the Humboldt Bay Trail has been a long time goal for Humboldt County residents because there is an immediate need for walking and biking trails for residents. She also said that the advancement of this project has been commendable and the increase in trail use is a major public benefit for the community and commuters. Mr. Sinkhorn also said that an active tourist train around the bay would greatly benefit the community and bring tourism and jobs to the county.

Pete Johnston, Timber Heritage Association (comment read aloud by Secretary)-Comments as follows:

Timber Heritage Association is fully behind the plan for trails around the Bay but has some serious concerns with the current 60% plan for the Bay Trail South project. These concerns were outlined in a letter sent to all NCRA directors and staff 10/7/20. Full text of that letter follows this comment card. In short, we feel the section that includes removal of the rail without plans for replacement needs to be addressed and feel the wooden deck/open flangeway option needs to be further vetted in the proposal.

Mike Pechner- Mr. Pechner said that he supports the THA's comments and concerns regarding retention of a rails with trails policy in Humboldt County that leaves open the potential for speeders and/or an excursion train to coexist with trail users on NCRA right of way in Humboldt County.

Director Marks – Dir. Marks said in 2009 when he was elected to the Humboldt Bay Recreation Conservation District one of his goals was to help create a hiking and biking trail around the bay. He said he is very pleased that we are finally making real progress toward the realization of that goal.

Hank Seemann- Mr. Seemann said that former NCRA Dir. John McCowen provided invaluable assistance in the development of rails with trails projects in Humboldt county. Mr. Seemann publicly thanked Dir. McCowen for all of his efforts in the development of rail with trail policy on NCRA right of way.

Mike Pechner – Mr. Pechner asked if the money from the state had been received. He then said that in 1989 the NCRA formed with no funding, no state agency can continue without funding, and Mr. Hemphill and Mitch Stogner kept the NCRA afloat despite the lack of funding. He also said that the NCRA is needed more than ever to protect the railway.

Mitch Stogner – Mr. Stogner responded to Mr. Pechner's comment and stated that the money is part of the state budget and has been encumbered to continue NCRA until a successor agency is named.

Director Haschak- Dir. Haschak asked what the status is for the line from Willits south to the county line and why can't that portion be railbanked?

Mitch Stogner- Mr. Stogner responded to Dir. Haschak and said that portion may be railbanked in the future, but at this time, the southern end of the line will be transferred to SMART as the designated freight carrier, and the line north through the Eel River Canyon will used for a multi-use trail.

Director Madrone – Dir. Madrone said he is in full support of this railbanking process and is available to help move this trail forward.

Director Marks – Dir. Marks said this is a sad day, trains will not be an option, but he is excited the NCRA is in support of a trail.

Mike Pechner- Mr. Pechner said the cost of a trail would be almost as much as putting the rail back in. He also said that the trail is absolutely negative and that dissolving the Authority is ridiculous.
