#### **G. OPERATOR REPORT** – Doug Bosco – Legal Counsel NWP Co.

Mr. Bosco introduced Chris Prevost. Mr. Prevost will be assisting NWP Co. in moving historic railcars to the Golden Gate Railroad Museum in Schellville for storage and future display at the museum. Mr. Bosco also said that NWP Co. has contracted to store around 160 empty LPG cars at the authorized location in Schellville.

Director Marks inquired as to whether NWP Co. will be involved in debris clean-up in Sonoma County resulting from the recent wildfire damages.

Mr. Bosco said that NWP Co. will not be assisting in hauling debris caused by the October 8 wildfire because the Corps. Of Engineers delayed a decision in appointing contractors for this debris removal project.

Director Breen inquired as to whether NWP Co. had the capability to run freight on the lines to Windsor?

Mr. Bosco said that NWP Co. does presently have that capability.

Mr. Bosco said that he appreciates Allan Hemphill's dedication to freight rail restoration and greatly admires his patience and determination. He said that Allan has given up so much of his personal time

because of his dedication to the railroad and he has been a great contributor to the rail restoration efforts on the North Coast.

#### I. LEGAL COUNSEL REPORT – CJ Neary

Mr. Neary introduced Jennifer O'Brien. Mr. Neary also thanked Allan Hemphill for his years of service and explained that Mr. Hemphill ran the railroad for a number of years in the 1990's.

Dir. Kelley said he was pleased that NWP Co. will be storing LGP cars again.

Dir. McCowen said he is aware that the City of Willits and the Ukiah Valley Trail Group have shown interest in constructing a trail in the Willits area and he requests that we add this to the next Agenda to show NCRA support of this project.

Dir. Marks announced the grand opening of the Eureka Trail which runs from the northern part of Eureka to the southern part. He also that the Harbor District will be welcoming the first cruise ship out of 5 in the next year. He said that Timber Heritage is looking into the logistics of running a speeder train to assist passengers.

Dir. Fennell said that Humboldt County was nominated by World Traveler magazine as the #1 destination in the U.S. this year. She also said that the Humboldt County Supervisors re-appointed Dir. Marks to the NCRA Board.

Dir. McCowen asked that the Exec. Dir. review the agreement with Timber Heritage and to make any needed adjustments and bring them before the Board for approval.
