D. PUBLIC COMMENT

Bruce Silvey- (emailed Public Comment to Clerk of the Board 6/6/2020)

We at the Humboldt Trails Council are glad to hear that NWP Co. and SMART have made an agreement for SMART to take over the operations of passenger and freight rail services from Cloverdale south. However, after considerable research we are concerned that the NCRA may take some actions that could inadvertently jeopardize the ability of the northern half of the NCRA corridor to be protected by Federal rail-banking.

We are confident that Senator McGuire and his staff, as well as the current NCRA Directors are supportive of rail-banking, but we are concerned that the order of future decisions could foreclose the option. Since the NCRA is still the legal authority of the 300 mile corridor, your actions appear critical.

Our understanding is that for the STB to be able to grant rail-banking protection, a railroad authority that is connected to the national rail network must file to abandon part of their corridor to a trail agency or themselves. If the NCRA corridor south of Cloverdale is severed from the northern part before railbanking is filed, there seems to be a high probability that the northern half will fall outside the jurisdiction of the STB.

Also, if the NCRA ceased to exist, or approved removal of tracks for trail expansion before rail-banking, we believe the same thing could occur. Since law is never as clear as it seems, we are requesting that the NCRA Board direct Executive Director Mitch Stogner to contact the STB to set up a consultation for the Board with an STB attorney.

Gabriel Myer, STB Attorney-Advisor 202 245 0150 (direct) said this could be arranged at no cost. Thank you for your attention to this important matter.
