**G. STAFF REPORT –** Mitch Stogner – Executive Director

Mr. Stogner asked Legal Counsel to summarize the current railbanking status.

Elizabeth Coleman, Legal Counsel – Ms. Coleman said that Notice of Exempt Abandonment with a request to railbank has been filed with the Surface Transportation Board (STB) with respect to milepost 139.5 north. She said that the environmental assessment and the historical report have been accepted by the STB and comments were made. If NCRA decided to move forward with the railbanking, NCRA will not need to address those comments. Due to the size of this filing, the STB is taking more time than usual reviewing this filing which covers almost 175 miles from Willits to Eureka including 3 branch lines. Once a publication is made by STB in the Federal Register, a period of time must pass that allows 3<sup>rd</sup> parties to make filings.

# H. MATTERS FROM THE BOARD

Director Madrone- Dir. Madrone said that Humboldt County has been holding workshops for landowners that own property that may include a railroad easement. He also said that several private property owners within the canyon are the underlying fee owners of property over which a rail easement exists and may have rights to a claim under the federal Tucker Act.
