
With regard to your request that NCRA release its Notice of Intent to Preserve interest for the benefit of your client's property located at 322 Lakeville in Petaluma I requested from you a google map which you provided. However, the map you provided was set forth at a scale in which it was not possible to ascertain the general location. I reviewed the google map webpage myself and it appears that the property is near the SMART station in downtown Petaluma.

NCRA and SMART recently entered into a transaction where it abandoned track near Hunt and Behrens. If the track bisecting your client's property had been cut off by that transaction I would recommend to my client that it execute the document as an accommodation.

However, in that your client's location appears to be not to be in a location affected by the recent abandonment your request needs to be approved both by SMART and by our Operator, Northwestern Pacific Railroad Company. I suggest that you start by contacting SMART and NWPCO and securing their consents prior to the consideration of the NCRA.

Also would you provide any documentation as to the factors that Old Republic is considering it would be appreciated.
