



Client Status Report For North Coast Railroad Authority (NCRA)

July-August 2018

Summary

Since 2013, FEC Real Estate Services (FEC), formerly Parallel Infrastructure, has successfully generated over \$310K in revenue for NCRA's Right of Way (ROW) portfolio. FEC continues to pursue prospective opportunities which could generate over \$20K in new income.

Areas of potential interest are listed below:

- The 20 year grade crossing license agreement with Recology Inc. has been finalized and executed. A onetime license fee of \$25,000 for the grade crossing located in Samoa (MP 300.9) was paid in exchange for the license.
- A fifty (50) year license agreement has been finalized with Humboldt Bay Municipal Water District (HBMWD) that will allow them to relocate Electrical Switchgear Equipment to higher ground
- The Hopland Municipal Advisory Council is interested in using a portion of the NCRA ROW to set up additional parking near the town center. Currently, much of the property is under another license agreement. We are working to develop a beneficial solution to all parties in order to maximize the use of the property.
