### **ADDITIONS TO AGENDA**

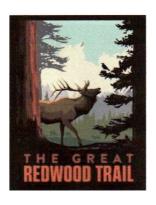

### D. PUBLIC COMMENT

Craig Benson, Humboldt Bay Harbor District Commissioner/Cal Poly Alumni- Mr. Benson thanked the board for coming to Humboldt County and voiced a huge amount of support for the once in a generation Great Redwood Trail. He said the community is very excited about the trail, and he reiterated that public and private partnerships along the rail line are of great value, especially in the Eel River Canyon because that area is a huge concern. The long-term maintenance and care would benefit from partnership with local utilities.

Bruce Silvey, Humboldt Trails Council- Mr. Silvey welcomed the Board to Humboldt County and said that hybrid meetings would allow the public to attend GRTA meetings.

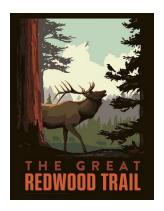

2023-03 and Environmentally Preferable Purchasing and Practices Policy,

as required by CalRecycle Grant Application for Calpella

### Background:

In September, GRTA staff submitted a grant application for \$250,000 to CalRecycle to clean up the contents of GRTA's Calpella building. CalRecycle requires (by 10/25/23) (1) a Board Resolution authorizing the application submittal and (2) that GRTA develop, adopt, and implement an Environmentally Preferable Purchasing and Practices Policy.

### **Staff Recommendation:**

Staff requests that the Board consider, approve, and adopt the following items as required by CalRecycle grant and payment programs:

- 1- A Resolution (Exhibit A) authorizing submittal of application(s) for all CalRecycle Grant and Payment Programs for which the Great Redwood Trail Agency is eligible.
- 2- An Environmentally Preferable Purchasing and Practice Policy, as a component of NCRA/GRTA Policy 0600 Procurement of Supplies, Equipment and Services. See Exhibit B for proposed language for this EPPP policy.

# (Exhibit A) Great Redwood Trail Agency Combined CalRecycle Grants and Payment Program Resolution

# Resolution 2023-03 of the Great Redwood Trail Agency authorizing submittal of application(s) for all CalRecycle Grant and Payment Programs for which Great Redwood Trail Agency is eligible

Whereas, Public Resources Code sections 48000 et seq., 14581, and 42023.1(g), authorize the Department of Resources Recycling and Recovery (CalRecycle) to administer various grant and payment programs in furtherance of the State of California's (state) efforts to reduce, recycle and reuse solid waste generated in the state thereby preserving landfill capacity and protecting public health and safety and the environment; and

**Whereas**, in furtherance of this authority, CalRecycle is required to establish procedures governing the administration of the payment programs; and administration of the application, awarding, and management of the grant programs; and

**Whereas**, CalRecycle's procedures for administering payment and grant programs require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of the payment and grant program.

**Now, therefore, be it resolved** that Great Redwood Trail Agency is authorized to submit an application to CalRecycle for any and all grant and payment programs offered; and

Be it further resolved that the Interim Executive Director, or her designee is hereby authorized and empowered to execute in the name of the Great Redwood Trail Agency all documents, including but not limited to, applications, agreements, amendments and requests for payment, necessary to secure funds and implement the approved grant or payment project; and

**Be it further resolved** that these authorizations are effective from the date of adoption through October 19, 2028.

### 0600. Procurement of Supplies, Equipment, and Services

### 0606. Environmentally Preferable Purchasing and Practices Policy

### **BACKGROUND**

The Great Redwood Trail Agency (GRTA) is committed to provide environmental leadership through policy development and implementation.

By incorporating environmental considerations in its purchasing, the GRTA can serve this commitment by reducing its burden on the environment, removing unnecessary hazards from its operations, protecting public health, reducing costs and liabilities, and improving the environmental quality of the region. This policy is an effective way to direct the GRTA's effort in procuring environmentally preferable products and services.

### **PURPOSE**

The primary purpose of this policy is to minimize negative environmental impacts of GRTA's activities by seeking the procurement of services and products that:

- Conserve natural resources, materials, and energy.
- Maximize recyclability and recycled content.
- · Reduce toxicity.
- Support markets for recycled goods and other environmentally preferable products and services.

### **DEFINITIONS**

The following terms shall have the assigned definitions for all purposes under this policy:

- A. Environmentally Preferable Products and Services means products and services that have a lesser or reduced effect on human health and the environment when compared with competing products that serve the same purpose. This comparison may consider raw materials acquisition, production, manufacturing, packaging, distribution, reuse, operation, maintenance, or disposal of the product.
- B. Life Cycle Cost means the amortized annual cost of a product, including capital costs, installation costs, operating costs, maintenance costs, and disposal costs discounted over the lifetime of the product.
- C. Practical means sufficient in performance and available at a reasonable price.
- D. Recyclable Product means a product which, after its intended end use, can demonstrably be diverted from GRTA's solid waste stream for use as a raw material in the manufacture

of another product.

- E. Recycled Material means material and byproducts that have been recovered or diverted from solid waste and have been utilized in place of raw or virgin material in manufacturing a product. It is derived from post-consumer recycled material, manufacturing waste, industrial scrap, agricultural waste, and other waste material, but does not include material or byproducts generated from, and commonly reused within, an original manufacturing process.
- F. **Virgin Material** means any material occurring in its natural form. Virgin Material is used in the form of raw material in the manufacture of new products.

### **POLICY**

The Great Redwood Trail Agency shall make best efforts to:

- 1. Procure environmentally preferable products and services where staff is able to identify and apply criteria that have been established by governmental or other widely recognized authorities (e.g., DGS' Buying Green Guide, Energy Star, EPA Eco Purchasing Guidelines).
- 2. Integrate environmental factors into GRTA's buying decisions where established authoritative criteria do not exist or, in the GRTA's discretion, cannot reasonably be applied. Examples include:
  - Replacing disposables with reusables or recyclables.
  - Supporting eco-labelling practices by buying products bearing such labels in preference to others, where they are available and provide value.
  - Taking into account life cycle costs and benefits.
  - Evaluating, as appropriate, the environmental performance of vendors in providing products and services.
- 3. Raise staff awareness of environmental issues affecting procurement by providing relevant information and training.
- 4. Encourage suppliers and contractors to offer environmentally preferable products and services at competitive prices.
- 5. Encourage providers of services to consider environmental impacts of service delivery.
- 6. Comply with all environmental legislative and regulatory requirements in the procurement of products and services.

Nothing in this policy should be construed as requiring the agency or its contractors to procure products that do not perform adequately for their intended use or are not available at a reasonable price in a reasonable amount of time. Procedures and Guidelines may be established as necessary to ensure the continuation of a strong Environmental Procurement Program.

### Responsibility

The GRTA shall strive to identify and purchase the most environmentally responsible products and services that are available for the intended purpose that meet performance requirements. Factors that should be considered when determining the environmentally preferable good or

### service include, but are not limited to:

- Minimization of virgin material use in product or service life cycle.
- Maximization of recycled products used in product or service life cycle.
- Environmental cost of entire product or service life cycle.
- Reuse of existing products or materials in product or service life cycle.
- Recyclability of product.
- Minimization of packaging.
- Reduction of energy/water consumption.
- Toxicity reduction or elimination.
- Elimination of uncertified hardwoods in product or service life cycle.
- Durability and maintenance requirements.
- Ultimate disposal of the product.

### Administrative and Management Staff Goals:

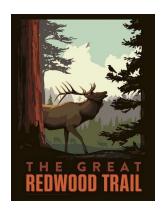
- 1. Maintain information about environmentally preferable products and recycled products containing the maximum practical amount of recycled materials, to be purchased by the agency, consultants, and contractors whenever possible.
- 2. Require the use of recycled materials and recycled products by incorporating them in bid specifications where practical.
- 3. As appropriate, disseminate information on recycled and environmentally preferable product procurement requirements, specifications, and performance to assist consultants and contractors.

### Agency Goals:

- 1. Consider the extent to which the specifications for requested product and services could include an environmentally preferable option.
- 2. Strive for the inclusion of environmentally preferable products and recycled products into contract requirements wherever practical.
- 3. Expand the awareness and use of environmentally preferable products throughout the agency.

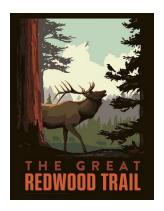
Agreement with DA MN Enterprises, LLC.

American Rail Engineers Corp. (ARE) is currently providing rail engineering services to GRTA under a contract last modified in 2022, and expiring in December 2023. Engineer Dave Anderson, PE and financial/administrative manager Angel Lucero, formerly of ARE, have been providing engineering support to GRTA in its current statutory form, and previously to North Coast Railroad Authority, for more than 20 years, including general engineering consulting and support, as well as providing technical expertise in support of GRTA's ongoing railbanking efforts. DA MN Enterprises, LLC, is a limited liability company owned and operated by Mr. Anderson and Ms. Lucero, providing engineering and consulting services.

DA MN Enterprises, LLC is willing to provide ongoing, as-needed engineering and consulting work on behalf of GRTA, at a rate of \$150 per hour for standard services, which is lower than the existing contract rate with ARE Corp. Such an agreement will provide a continuity of key personnel and services to GRTA as ongoing need arises.

### **Staff Recommendation:**

In order for GRTA to continue receiving critical professional on-call engineering and related services from its long-time rail engineer Dave Anderson, staff recommends the Board delegate to the Interim Executive Director authority to enter into a professional services agreement with DA MN Enterprises, LLC, in a form approved by counsel, in an amount not to exceed \$90,0000, for work to be performed upon the direction of the Interim Executive Director.
