Re: Request To Be Added To The January 25, 2024 Board Agenda

I am writing you on behalf of Wailaki and Cahto tribal elders and concerned individuals that have formed the Kinest'e Community Collation to protect and preserve their culture because your agency has not yet shown signs of respect and concern for their potential losses regarding the Great Redwood Trail ("Trail") being planned by the Great Redwood Trails Agency ("GRTA").

The Indigenous Peoples since time immemorial have inhabited, and called home, the land slated be dedicated to the Trail. Their way of life is intertwined with this landscape and watershed. Their ability to sustain cultural practices, hunt and gather, and exercise religious freedom is dependent on the land in a way no other group of people can claim or assert.

So far, based on community meetings and reviews of your website and planning documents, we believe that the GRTA has not provided a culturally-appropriate means for input by Indigenous Peoples. We also believe the GRTA has not fully understood nor provided for protection of indigenous cultural resources along the Trail's proposed path. The Trail's construction has the potential to disturb or destroy many aboriginal title areas of the Yurok, Wiyot, Mattole, Wailaki, Sinkyone, Cahto, Yuki, Miwok, and Pomo peoples. It is concerning that the GRTA is not actively engaging with these communities and individuals to ensure aboriginal spaces will be protected and preserved in a way that honors the original inhabitants who have aboriginal claim, original Indian title, and right of occupancy.

For this reason, the first people of this area are respectfully requesting that they be treated as the original peoples of the land and be given the respect due. In action, this letter serves as an opening of dialog and a formal request that these community members are welcomed to the January 25, 2024 board meeting to express their deep concerns regarding the Trail and the damage it would inflict on their peoples' current and ancestral homelands. Fulfilling our request will allow you all to hear, and perhaps begin to understand, how the proposed trail is not compatible with the diverse uses and meaning for the Indigenous Peoples who have always claimed the area as home. Ignoring our request will be an indication of disinterest in hearing Indigenous voices.

The GRTA, as a State agency, must be in compliance with all of the Federal and State laws protecting cultural resources including prehistoric and ethnohistoric Native American archaeological sites, historic archaeological sites, historic buildings, and elements of areas of the natural landscape which have cultural significance. These laws including the California Environmental Quality Act, National Historic Preservation Act of 1966, National Trails System Act, the Scenic and Wild Rivers Act, Native American Graves and Repatriation Act and others all have parts which apply to the actions of the GRTA. In addition, there are many other California statutes surrounding the recognition, discovery, and handling of Native American remains and cultural objects, including California Code of Regulations, Title 14, Section 4308<sup>1</sup> and California

Code of Regulations, Title 14 section 1427<sup>2</sup>. There is much to discuss about these laws and who and what they are protecting.

Thank you very much for making an hour available on the January 25, 2024 agenda to begin a very important dialog. We look forward to meeting in person.





The City of Willits ("City") seeks a license agreement to construct, operate, and maintain a 1.6-mile-long Class 1 rail-with-trail segment of the Great Redwood Trail in the GRTA right-of-way, between East Hill Road and East Commercial Street in Willits, Mendocino County, California.

The City plans to start construction of this segment of the Great Redwood Trail in summer 2024. Funding for the construction has been approved by the Active Transportation Program (ATP), administered by Caltrans, and the State Coastal Conservancy.

#### **Staff Recommendation:**

Staff recommend the Board authorize the General Manager to approve a license agreement for construction, operation, and maintenance of a 1.6-mile segment of the Great Redwood Trail, between the Great Redwood Trail Agency and the City of Willits, in a form approved by counsel.

and the City of Blue Lake

The City of Blue Lake (City), a municipal public entity in Humboldt County, seeks a renewal of their existing lease for use of GRTA property. Since 2019, the City has built and operated a 0.5-mile public multi-use path, locally known as the Annie and Mary Trail, in Blue Lake under a lease to use GRTA parcels along the former Arcata & Mad River Railroad right-of-way. This agreement was for five years from execution, unless terminated. In consideration for use of the property, the City provides maintenance for the trail and surrounding property. The City seeks the following updates on a renewal of their lease:

- 1. Update the language of the agreement to recognize the name change from NCRA to GRTA.
- 2. Extend the lease term to 25 years, with a new term date of 2049, with the power to effect additional 25-year extensions to the new lease term if both parties elect to do so.
- 3. Include a "community park" as an additional allowable use for the GRTA property, to allow for the City's development of additional trail amenities, with the limitation that the property may not be dedicated to park use.

#### **Staff Recommendation:**

Staff recommend the Board authorize the General Manager to approve a lease agreement between the Great Redwood Trail Agency and the City of Blue Lake in substantially the form attached.

#### LEASE AGREEMENT

THIS LEASE AGREEMENT ("Agreement" or "Lease") is made by and between the Great Redwood Trail Agency, a public agency formed pursuant to Government Code Section 93000 et seq. ("GRTA"), formerly known as the North Coast Railroad Authority ("NCRA"), and the City of Blue Lake, a municipal public entity ("City").

### RECITALS

- A. GRTA is the property owner of the section of the former Arcata and Mad River Railroad right-of-way ("A&M Rail Corridor") located within the City of Blue Lake in Humboldt County. The A&M Rail Corridor was a branch line of the mainline Northwestern Pacific Railroad railway right-of-way corridor (NWP Rail Corridor") starting at the junction located at Korblex, NWP post mile 295.57 (the north side of West End Road).
- B. NCRA adopted Resolution 2008-11 recognizing the A&M Rail Corridor as being appropriate for multi-modal transportation use.
- C. The City developed a non-motorized path within the GRTA property located in the City of Blue Lake jurisdictional area consistent with Senate Bills No. 1029 (2018) and No. 69 (2021) under a previous Lease Agreement that commenced July 1, 2019 and terminates June 30, 2024.
- D. The City seeks to continue maintaining the non-motorized path and add trail improvements such as a community park within the GRTA property located in the City of Blue Lake jurisdictional area consistent with Senate Bills No. 1029 (2018) and No. 69 (2021).
- E. GRTA desires to issue a lease to the City to use the A&M Rail Corridor for the Annie & Mary Trail Phase 1 section, and the City desires to accept such lease, on the terms and conditions set forth in this Lease Agreement.

**NOW THEREFORE**, in consideration of the mutual covenants, conditions and agreements recited herein and made a material part hereof, the GRTA and City agree as follows:

- 1. Definitions.
  - a) "Commencement Date" is defined in Section 4.
  - b) "A&M Rail Corridor" is defined in Recital A.
  - c) "NWP Rail Corridor" is defined in Recital A.

- d) "Lease Property" is defined in Section 2.
- 2. <u>Description of Lease Property.</u> The property subject to this Agreement (the "Lease Property") is defined as that specific section of the A&M Rail Corridor, beginning in the west at or near Chartin Road and terminating in the east at or near Shamrock Lane in Blue Lake, CA, specifically excluding therefrom any and all City roads and other City rights-of-way. The location of the Lease Property is depicted in Exhibit A hereto and incorporated herein by this reference.
- 3. <u>Use.</u> GRTA hereby grants to the City a non-exclusive lease to access and use the Lease Property to construct, install, maintain, reconstruct, remove, repair and manage a community park and multi-modal public path, for shared use by, including but not limited to, bicyclists, pedestrians, wheelchair users, joggers, and other non-motorized uses. Motorized vehicles shall be permitted access and use as needed by the City, its agents and contractors, for construction and maintenance purposes, and by emergency response personnel. City's use of the Property for park purposes shall not grant City the right or permission to dedicate any portion of the Property to parks use, and any attempted dedication by the City with respect to any portion of the Property under the California Public Resources Code or any other state or federal law shall be null and void and of no legal effect.
- 4. <u>Term.</u> The term of this Agreement shall be twenty-five (25) years (the "Term") commencing on June 30, 2024 (the "Commencement Date"), and unless sooner terminated or extended as herein provided, shall terminate on June 30, 2049. During the Term and any extensions of the Term, the Lease granted hereunder shall be irrevocable except as provided in Sections 10 and 12, below.
  - a) Extension of Term. Upon the election of both parties, evidenced by written notice provided by each party hereto of its election to extend no later than ninety (90) days prior to the completion of the existing term, this Agreement may be extended upon the same terms as set forth herein for additional twenty-five-year terms. The election by only one party to this agreement to extend its term shall be of no force or effect.
- 5. <u>Lease Fee.</u> In lieu of either a one-time or annual lease fee payment, the City shall provide maintenance to completed trail segments located in the Lease Property as follows:
  - a) City shall maintain drainage structures; and
  - b) City shall provide all vegetation management, including tree trimming and removal; and
  - c) City shall provide ongoing maintenance as described in (6) Ongoing Maintenance hereafter.

Said maintenance shall be performed to standards as determined by the City in its reasonable discretion, however in no event may the City use a lesser standard than that typically used in its maintenance of the City's other similar public trails and paths. The City, at its sole discretion and expense, may perform such additional maintenance as it deems appropriate within the Lease Property.

#### 6. Trail Construction

- a) Trail Construction, Timing. The City may construct trail improvements, including amenities that enhance trail access, such as a community park, in the Lease Property in segments as funding allows. Individual trail segments shall not be open for public use until completion of the trail improvement in said segment. Where required by permitting or other regulatory authorities, GRTA reasonably agrees to execute and deliver applications for permits, licenses or other authorizations relating to the Lease Property. Trail segments and amenities shall be constructed in accordance with approved Construction Plans, and all applicable laws, rules, regulations and permits. The City shall provide 15 days advance written notice to GRTA prior to beginning construction on any trail segment. The City shall provide 15 days advance written notice to GRTA prior to opening any trail segment for public use.
- b) Construction Plan Approval. The City shall submit detailed construction ready plans and specifications ("Construction Plans") to the GRTA or its successors and assigns for review and approval prior to constructing any trail segment. Within one hundred twenty (120) days of receipt, the GRTA shall provide comments and input on the Construction Plans to the City.
- c) Construction Plan Contents. Construction Plans shall include, but not be limited to, specifications for temporary construction fencing, permanent landscaping, fencing or other trail demarcation and setbacks, and signage.
- d) As-Built Plans. Upon completion of construction and acceptance of any segment, the City shall provide copies of As-Built Plans to GRTA.
- 7. Ongoing Maintenance. The City shall track the annual maintenance of the Lease Property. The City shall, during the Term, at its own cost and expense and without any cost or expense to GRTA:
  - (a) keep and maintain all trail improvements (subject to City's right to remove) in good and neat order and repair and shall allow no nuisances to exist or be maintained therein. GRTA shall not be obligated to make any trail repairs of any kind; and
  - (b) comply with and abide by all applicable federal, state, and local laws and regulations affecting the Lease Property.
- 8. <u>Insurance</u>. The City shall maintain general liability coverage in the amount of no less than \$2,000,000 per occurrence and aggregate. Insurance shall be placed with a carrier having a current A.M. Best rating of at least A:VII or with the Redwood Empire Municipal Insurance Fund ("REMIF"). Evidence of coverage shall be provided to GRTA annually. The policy shall include GRTA as additional named insureds with respect to the trail.

- 9. <u>Indemnification.</u> To the maximum extent allowed by law, the City agrees to indemnify, defend and hold harmless GRTA, including its officers, employees, operators, agents, contractors, successors and assigns, from and against all loss, liability (including liability with respect to death, injury and personal and property damage), claims, demands, suits, liens, claims of lien, damages, costs and expenses:
  - (a) arising out of the use or misuse of the Lease Property by members of the public, including claims which arise from utilization of the Minimum Clear Space adjacent to the Lease Property by users of the Lease Property;
  - (b) arising from the construction of improvements within or the maintenance of those improvements by the City or its contractors; or
  - (c) any negligent or wrongful act or omission by the City in constructing or maintaining improvements within the Leased Premises.

Such indemnity shall apply notwithstanding GRTA's active or passive negligence, and shall be deemed to apply, to any and all losses resulting from the City's negligent or wrongful acts or omissions. The City is not required to indemnify GRTA for claims or damages caused by the willful misconduct or the sole negligence of GRTA or its officers, contractors or employees. This provision shall survive any termination of the Lease for actions or inactions that may arise during the time this Lease is in effect.

10. <u>Assumption of Risk and Waiver.</u> To the maximum extent allowed by law, the City assumes any and all risk of loss, damage or injury. The City's assumption of risk shall include loss or damage to the City, its officers, employees, agents, contractors, and successors. The City hereby waives all claims and demands against GRTA for such loss, damage or injury, and waives the benefit of California Civil Code Section 1542, which provides as follows:

A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known to him must have materially affected his settlement with the debtor.

- 11. <u>Abandonment</u>. In the event of action by the City Council for the City of Blue Lake to abandon the use of the Lease Property, or any part thereof, this Agreement shall terminate to the extent of the portion so abandoned or discontinued.
- 12. <u>Surrender.</u> Upon termination of this Agreement, including but not limited to a termination resulting from expiration of the lease term, breach, or abandonment of all or a portion of the trail improvements, GRTA may direct the City to remove, at its own cost and expense, any and all trail improvements. Upon removal of any trail improvements, the City may, with the concurrence of GRTA, (i) reasonably restore the affected portion of the Lease Property to a state or condition as it existed prior to the construction of trail improvements, (ii) leave all or a portion of the trail improvements in place, or (iii) replace the trail improvements with comparable improvements approved by GRTA.
- 13. <u>Breach.</u> In the event the City breaches, or fails to keep, observe or perform any covenant, term or condition of this Agreement, in addition to all other rights and remedies of GRTA provided hereunder or by law, after written notice or demand, and

the City's failure to cure the breach within thirty (30) days of notice, or fewer days in the event the breach impacts public health, welfare or safety, unless the breach cannot be cured within that time in the exercise of reasonable diligence, in that event the City must commence to cure the breach within 30 days and complete the cure as soon as reasonably practical, GRTA may terminate this Agreement.

- 14. <u>Waiver</u>. No waiver of any default under this Agreement shall constitute or operate as a waiver of any subsequent default hereunder, and no delay, failure or omission in exercising or enforcing any right, privilege, or option under this Agreement shall constitute a waiver, abandonment or relinquishment thereof or prohibit or prevent any election under or enforcement or exercise of any right, privilege, or Option hereunder.
- 15. <u>Notices.</u> Except as otherwise provided hereunder; any notice or communication to GRTA, or the City shall be in writing and be mailed by postage prepaid. Notices or communications shall be addressed to the parties at the following addresses, which may be changed at any time by notice to the other party:


Any notice mailed in the manner above set forth shall be deemed to have been received unless returned to the sender by the post office. Notice may be sent by email when simultaneously provided using one of the methods set forth above.

- 16. <u>Severability</u>. In case any one or more of the provisions contained in this Lease shall for any reason be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provisions of this Lease, but this Lease shall be construed as if such invalid, illegal, or unenforceable provisions had not been contained herein.
- 17. <u>Time of the Essence</u>. Time is of the essence of each and all of the agreements, covenants, and conditions of this Lease.
- 18. <u>Consents.</u> Whenever in this Lease the consent or approval of either GRTA or City is required or permitted, the party requested to give such consent or approval will act promptly and will not unreasonably withhold its consent or approval.
- 19. <u>Attorneys' Fees.</u> In the event of any action or proceeding at law or in equity between GRTA and City to enforce any provision of this Lease or to protect or establish any

- right or remedy of either party hereunder, each party shall pay its own costs and expenses, including attorney's fees.
- 20. <u>Integration & Amendments.</u> This instrument constitutes the entire agreement between GRTA and City with respect to the subject matter hereof and supersedes all prior offers and negotiations, oral or written. This Lease may not be amended or modified in any respect whatsoever except by an instrument in writing signed by GRTA and City.

Dir. Mulheren – Ms. Mulheren said that a "Witches and Wheels" event was hosted along the Ukiah trail with great turnout and another event will be held around the Christmas holiday for the community to attend.
