Service Name: Willits Mowing in Railroad Corridor- 2025

The Great Redwood Trail Agency is seeking quotes from qualified vendors to provide mowing of grass and other vegetation in the railroad right-of-way between East Commercial Street and East Barbara Lane in Willits, CA. This RFQ outlines the requirements and submission process for quotes.

Description of Services


Service: Willits Mowing in Railroad Corridor- 2025

Scope of Work:

- Mowing of grass and other vegetation, as well as garbage removal to allow for mowing, in railroad right-of-way between East Commercial Street and East Barbara Lane in Willits, CA. Approximately 0.56 mile stretch of railroad corridor.
- Mowing does not include Himalayan blackberry bushes.
- Efforts will be made to mow around native California Poppies in the area.
- Garbage removal does not include active encampment materials.
- Proper disposal of removed materials in compliance with California State Water Resources Control Board (SWRCB) and Integrated Waste Management Board (CIWMB) regulations under Division 2, Title 27.
- Fire prevention measures will be taken:
 - o Fire extinguishers and fire suppression tools/equipment will be on site while work is performed. This includes a water truck with an operator.
 - o Work will be performed outside of the hottest part of the day
 - o Work will be performed based on the CalFIRE risk assessment classification

• Work is to be conducted along an active railway. GRTA will work with train operators and the contractor to coordinate the timing of work. Properly trained railway personnel will be provided at no additional cost to the contractor.

Service Location: Railroad Right-of-Way from East Commercial Street and East Barbara Lane in Willits, CA.

Timeline: Mowing must be completed no later than June 30, 2025

Prevailing Wage: No

Submission Requirements

Vendors must include the following in their quote:

1. Company Information:

- Name, address, and contact information.
- Company experience with fire prevention protocols.

2. Pricing:

- Itemized cost breakdown.
- Total cost, including any applicable taxes or fees.

3. Service Timeline:

Estimated start and completion date.

4. Compliance:

 Proof of licensing, insurance, and ability to comply with environmental regulations.

5. Changes to Agreement:

 Please note if there will be any changes needed to GRTA's posted "Sample Agreement for Professional Services."

<u>Insurance Requirements:</u> GRTA requires applicant, contractor(s), and subcontractors to hold \$2 million unrestricted liability insurance. GRTA must receive and approve a certificate naming GRTA as an additional insured party, for <u>all parties involved in the work before</u> work can begin.
